## About Ravenshaw University:

Ravenshaw University came into existence on the 15th day of November, 2006. It was an up-gradation of Ravenshaw College established in 1868, one of the oldest and largest colleges in India which subsequently became an autonomous college with CPE status by UGC and 'A' grade by NAAC. The College with all its glorious academic achievement and ceaseless scholastic pursuits had already created a distinct niche for itself in India and beyond. The history of this great institution is, in a manner of speaking, the history of modern Orissa. It was the cradle of ideas fostering national unity and nationalism, promoting social mobilization and gearing up the freedom struggle. ## About the Seminar

Growth and prosperity of a country squarely rest of quality and excellence of higher education. Accordingly the curriculum and evaluation practices are two important base for quality and excellent higher education. Unprecedented growth of the student population as well as growing mobility of student forces across the globe for career opportunities requirs a comprehensive plan for reforms particularly in examination system in higher education. "If we are to suggest one single reform in University Education, it should be that of examinations."-Radha Krishnan Commission, 1948. The statement clearly points finger on validity and reliability of our evaluation system. Compatibility and concern for students' all round development are the basic requirements of effective educational process. Problem of examination is the most taxing problem of education. The unfortunate consequences of the present system of examinations are imposition of a common examination across hundreds of centers (colleges) entails a significant loss of sensitivity to local conditions and flexibility in a more general sense; tertiary-level education is marked by the dominance of the external final examination; emphasis on final/terminal results makes the approach to teaching/learning similar to that associated with competitive examinations, namely, tuitions and coaching; undue focus on getting good marks' in the final examination; Low-level questions asking only for memorization, poorly worded questions and the consequent inconsistency in marking, and other similar flaws have persisted despite repeated calls for rectification. The inertia in the system is the root cause that needs to be understood and tackled. If we can solve it satisfactorily, there will be a great relief to the both students and parents, the very face of education would be different.

In order to reform the examination system in our country, the Mudaliar Commission (1952) laid stress on the use of objective type tests and internal assessment. Kothari commission (1964) too reiterated these reforms. This Commission boldly suggested that the certificate of the student should bear his complete performance but there should be no remark to the effect that he has passed or failed in the whole examination. The National Policy on Education (1986) and POA (1992) emphasized on continuous and comprehensive evaluation and the introduction of semester system from the secondary stage. Recently NCERT in its NCF-2005 emphasized on varied modes of assessment, flexibility in exams and enhanced reporting of performance etc. The main focus of NCF-2005 are child friendly, humanistic and authentic evaluation practices at school level. Accordingly, UGC recommended Semester System and Choice Based Credit System (CBCS) for colleges and Universities. Under this system, students can choose subjects on their own also ask the examiner to conduct the examination when the students are ready for them. Subjects are not imposed on students in the CBC system, nor the date of examination. While the CBC system has been operative in several countries since quite some time now, in India very few universities have introduced this system so far. As per order of Department of Higher Education, Govt. of Odisha, all the colleges and Universities have adopted semester system of examination and CBCS. Since a number of developments and reform-oriented measures like syllabus review and revision; increased frequency of public examinations; introduction of internal assessment; development of question banks; changeover to a grading system; semesterisation; and, creation of autonomous colleges have been initiated in the state in recent years. It is important to review progress that has been made so as to strength this base. The seminar will focus on below mentioned sub themes:

## Objectives:

Keeping in view need of examination reform, the seminar shall have the following objectives
