1. GENERAL TERMS AND CONDITIONS:

1.1 The bidder must be reputed and registered Agencies / Firms / Caterers having minimum five years of experience in similar works in the field of catering services to any Government Educational Institutions/ Universities with minimum annual turnover of 30 lakhs (Rupees: Thirty lakhs) for last three years.

1.2 The bidders are required to accept all terms & conditions mentioned in the Tender Document. Ravenshaw University, Cuttack reserves the right to reject any or all offers without assigning any reason thereof.

1.3 It is the responsibility of the bidders to read all terms & conditions of the Tender Document before filling the tender. Incomplete Tender Documents or Bids are liable to be rejected.

1.4 The tenders received after the stipulated date and time will not be acceptable.

1.5 Ravenshaw University, Cuttack, Odisha also reserves the right not to accept the lowest bid if any discrepancy found.

2. BID FEE & EARNEST MONEY DEPOSIT:

The tender document shall be submitted through Registered Post/Speed Post / Courier / by hand only to the Purchase Officer, Ravenshaw University, College Square, Cuttack-753003, Odisha duly signed by the authorized signatory in each page and duly authenticated with seal of the firm/agency along with 02(Two) separate Demand Drafts drawn any nationalized bank one of Rs. 2,000/- (Rupees Two thousand only) towards cost of tender paper and amount of Rs.50,000/- (Rupees Fifty thousand only) towards EMD in favor of "Ravenshaw University, Cuttack" drawn any scheduled bank payable at Cuttack so as to reach on or before 19.03.2026 by 1.00 PM.

Please note that offers not accompanied by the required EMD and Tender cost will be rejected.

Offers submitted with incomplete information will not be considered.

3. SCHEDULES OF TENDER:

The Tender Document will be available in the website of Ravenshaw University, Cuttack, Odisha (www.ravenshawuniversity.ac.in) for download. The intended bidders may download the same from the website.

3.1 Ravenshaw University reserves the right for not inviting the disqualified bidders in Technical Bid, while opening the Financial Bids.

3.2 Any tender received after the date and time given above will not be entertained under any circumstances.

3.3 The Competent Authority reserves the right to reject any or all tender without assigning any reason and shall not bind it to accept any tender and reserves the right to call for fresh tender.

3.4 PROCEDURE FOR SUBMISSION OF BIDS:

The Bids shall be submitted in three separate sealed A4 Size envelopes as under:-

- a) Envelop A- should contain the Bank drafts for the Earnest Money Deposit (EMD) ,Bid Fee along with the details in (Annexure-I) and all documents as per Annexure and the documents in support of the details furnished superscribed as Envelop 'A' (Documents) .
- b) Envelop B- should contain the Technical Bid Document, (Annexure-II). Tender Document duly signed by the bidder on each page and all necessary documents to be submitted along with the Technical Bid superscribed as Envelop 'B' (Technical BID)
- c) Envelop C- should contain the Financial Bid Documents (Annexure-III) superscribed as Envelop 'C' (Financial BID).

3.5 All three sealed envelopes (i.e., envelopes A, B & C) should be kept inside a larger envelop duly sealed, addressed to the "Purchase Officer, Ravenshaw University, College Square, Cuttack, Odisha-753003" and super scribed "**Tender for Supply of Food during Odisha State Level Inter University Literary-Cultural Meet 2025-26**" may be submitted through **Registered Post/Speed Post/ Courier/Hand delivery** only on or before 19.03.2026 by 1.00 PM. The cover should also bear the name and address of the bidder including telephone number and e-mail id.

3.6 The bidder must put his seal and signatures on each page of the bid and also attest all or corrections etc., if any, under his seal and signatures.

4. BIDDER QUALIFICATION:

4.1 The bidder should have minimum five years of experience in the field of providing catering services to Govt. Educational Institutions / Universities (Copies of such work orders should be enclosed).

4.2 The minimum annual turnover of the prospective bidder should be Rs. 30 lakhs during the last three preceding years i.e. 2022-23, 2023-24 & 2024-25 (Audited copy of the same shall be attached in the technical bid).

4.3 The Bidder should have a required license issued by Food Safety and Standard Authority of India (Attested copy should be attached with Technical Bid).

4.4 Copy of PAN, Audited Balance Sheet, GST Registration certificate, Valid Firm / Agency Registration Certificates issued by competent authorities copy shall be enclosed in the technical bid.

4.5 The Bidder should not have been black listed by the Departments of State Govt. / Govt. of India Organizations.

4.6 All the information submitted by the Bidder shall be presumed to be true to be best of the knowledge of the bidder.

5. SCOPE OFWORK:

5.1 To provide fresh & hygienic food as per the prescribed Menu given in Tender for Odisha State Level Inter University Literary-Cultural Meet 2025-26 from 28 to 31 March 2026.

5.2 The Breakfast and Dinner will be prepared and served in the Mahanadi Campus.

5.3 Lunch and Snacks will be served in the Main Campus.

5.4 The serving of the food items is the responsibility of the bidder.

5.5 The serving utensils including plates, glass and drinking water will be provided by the bidder.

5.6 The garbage must be disposed off immediately as per CMC guidelines.

6. **TERMS AND CONDITION OF BID:**

6.1 The bids must be accompanied with a Demand Draft issued by any Nationalized Bank for Rs. 50,000/- (Rupees Fifty thousand only) in favour of Ravenshaw University, Cuttack payable at Cuttack towards EMD.

6.2 The Technical Bids shall be opened at Office of the Registrar, Ravenshaw University, Cuttack by a duly constituted **Purchase Committee** and **Cultural Council** in the presence of such bidders or their authorized representatives who may desire to be present at the time of opening of bids.

6.3 It is the responsibility of Bidders to read all terms & conditions of this document carefully before filling the bid. Incomplete bid documents or bids not responsive enough to the terms & conditions are liable to be rejected. The bidder should sign undertaking along with the bid document that he has read the complete tender document and will abide by its terms & conditions.

6.4 The bid shall contain no erasures or overwriting except as necessary to correct errors made by the bidder, in which case such corrections shall be authenticated by the person or persons signing the bid.

6.5 Bid documents are neither transferable nor cost of the bid documents is refundable under any circumstances.

6.6 If even after award of contract, information/facts submitted by the bidders are found misleading/incorrect/false etc., Ravenshaw University, Cuttack reserves the right to terminate the contract.


6.7 The Earnest Money Deposit will be refunded to the unsuccessful bidders within one week of the date of approval of the successful bidders without any interest.
