**GUIDELINES FOR ENROLMENT INTO THE Ph.D. PROGRAMME BY
EXTRAORDINARY ACHIEVERS / PERSONS OF EXCELLENCE
FROM THE FIELD OF INDUSTRY, CORPORATE AND
GOVERNMENT ORGANISATION**


A. Objectives and Eligibility:

As a part of Industry-University interface, persons of excellence or extraordinary achievers from the field of industry, corporate and government organizations may be allowed to take admission in Ph.D. programme of Ravenshaw University, Cuttack under the following terms and conditions:

1. A maximum of 2% of the total number of Ph.D. students enrolled / admitted/ registered in an academic year will be available for the extraordinary achievers / persons of excellence from the field of industry, corporate and government organizations. Such admission shall be treated as supernumerary to maintain the availability of seats to the regular students.
2. The enrollments of above candidates are subject to vacancy under the supervisor(s) of concerned departments.
3. The eligibility of students will be same as the eligibility for admission into regular Ph.D. programme of this University notified from time to time.

B. Application Process:

1. The application shall be open throughout the year and interested candidates (extraordinary achievers/ persons of excellence) are free to apply in prescribed form (Annexure-I) with all documents to the Chairman, Post Graduate Council (CPGC) in physical mode.
2. The applicants are required to attach all documents as notified in University Admission Boucher including NOC from the Organization/Institution where he/she is in regular service.
3. The NOC shall clearly mention that the candidate, once selected for admission to Ph.D. programme, shall be allowed leave to appear examinations, and all other activities relating this programme till completion of the degree.

C. Selection Process:

1. After receiving the application(s), the eligibility and credential of applicant(s) shall be examined by a Committee duly constituted for this purpose (notified by the Chairperson, PG Council) which shall include Chairperson P.G. Council (Convenor), One VC nominees from other discipline that applied for, Head of the concerned department and COE.
2. The Committee shall refer the cases of all eligible candidates to the DRC. The DRC shall examine all other matters relating to admission and submit the report along with filled up admission form, approved synopsis (if applicable), name of the allocated supervisor, etc. to the Coordinator, Admission Committee of the concerned academic year for final admission.
3. After admission into the Ph.D. programme, the Coordinator, Admission Committee will send all the relevant documents to the COE for issue of registration letter after due approval of the Vice Chancellor.

D. Guidelines and Regulations:

1. Ph.D. course work will not be mandatory for the scholar of this category.
2. All other regulations including submission of progress reports, fees, examination, thesis submission, time-period, etc. shall be same as applicable to regular students enrolled under Ph.D. programme in the concerned academic year.
3. In case of any disputes regarding the matters not covered in this guideline the decisions of the Vice Chancellor shall be final and binding.
