This is notify that the following Ph.D 1st year students are provisionally selected for hostel accommodation for the **session 2024-25**. For hostel admission, they are required to produce **University admission fee transaction receipt, Resident Certificate and Aadhar Card** and filled in Hostel admission form available on university website in the office of the Chief Warden. On successful verification of the documents, the students need to pay:

1. Establishment Fee of **Rs. 4300/-** (Four Thousand Three Hundred only) by Debit/Credit card through Swipe Machine in the office of the Chief Warden. This includes Hostel Establishment charge (**Rs. 2300/-**) and Mess establishment charge (**Rs. 2000/-**).
2. Annual electricity charge of Rs. 785/- (Seven Hundred Eighty five only) online mode-

Subsequently, they will take admission in their allotted hostel during the hostel office hour by producing receipts of the above payments and paying caution money of **Rs 500/-**, Maintenance fee **Rs. 1000/-** and Mess advance **Rs. 1500/-** through swipe machine in the hostel. The hostel admission will be held from ^{3rd} **May 2024 to 9th May 2024 (Time: 11.00 AM – 4.00 PM)** excluding holidays and 2nd & 4th Saturday. **The Guardian/Parent and Local Guardian are requested to be present at the time of hostel admission along with their identity proof documents.**

NB: 1. Resident certificate should be issued from Office of the Tahasildar (For state of Odisha) and Domicile Certificate issued from State Government / Central Government (For other states). Resident Certificate issued in or after the year 2020 will be considered for hostel admission.

2. Boarders cannot keep motor bikes in the hostels.
3. During their stay in the hostels, students cannot avail of HRA as part of their fellowship or scholarship.
4. Admission to hostel is valid for only one session (2024-25)
